Kentucky Department of Revenue records indicate that you were a vendor at the **2026 MID-AMERICA TRUCKING SHOW** in **LOUISVILLE**, **KENTUCKY** held on **MARCH 26-28, 2026**. KRS 139.200 imposes a 6% sales tax upon all retail sales and sales of certain services made within the Commonwealth.

If you currently hold a Kentucky Sales and Use Tax Permit, you are to report the activities of this event on that permit number. Please provide the name as shown on the permit and the Kentucky sales and use tax permit number in the area designated below.

If you are not registered for a Kentucky sales and use tax permit number, you must complete the bottom portion of this letter and return it with payment of the tax due to the address shown on this letter. KRS 139.550 requires temporary vendors to timely report and remit sales tax to the Department of Revenue.

The Temporary Vendor Sales and Use Tax Return and tax payment may be submitted electronically by registering at MyTaxes.ky.gov.

Vendors must complete these steps by 20th day of the month following this event to avoid accrual of penalty and interest. For example, if an event is held on April 5, sales tax payment would be due by MAY 20. If no response is received, a jeopardy assessment may also be assessed pursuant to KRS 131.150
